# **BEAM Affiliate Training and Examination Programme**



## Introduction

A BEAM Affiliate is a person accredited by the Hong Kong Green Building Council Limited (HKGBC) as being competent to support green building design, construction and operations. The BEAM Affiliate Training and Examination, organised by BEAM Society Limited (BSL), aim at equipping participants with knowledge in green building in the areas of design, construction, operation and maintenance, as well as the BEAM Plus rating tool.

The programme welcomes practitioners or technical staff working in the construction/real estate industry, interior design practitioners, or recent degree graduates who are in the process of working towards a professional qualification. The credential also provides an individual who cannot yet meet the BEAM Pro requirement with an alternative route to becoming a BEAM Pro.

### **Training Programme**

The training includes BEAM Plus New, Existing Buildings & Interiors rating tools associated with major components, namely *Introduction* to BEAM Plus Framework and Innovations (IA), Site Aspects (SA), Materials Aspects (MA), Energy Use (EU), Water Use (WU) and Indoor Environmental Quality (IEQ). Trainers are invited from the Green Building Faculty, which consists of a group of experts and professionals that supports the initiatives of green building and sustainable environment in Hong Kong.

The 6<sup>th</sup> BEAM Affiliate Training and Examination is now open for registration on a first-come-first-served basis.

## **Minimum Qualification Requirements**

To enrol for the Training and Examination, you must fulfill one of the following:

A degree or equivalent in a built environment-related discipline; <b>plus</b> At least <b>2 years'</b> working experience in the building, construction or interior design industry.	OR
A diploma or equivalent in a built environment-related discipline; <b>plus</b> At least <b>5 years'</b> working experience in the building, construction or interior design industry.	OR
At least <b>10 years'</b> working experience in the building, construction or interior design industry, with completed education at <b>HKCEE/HKDSE</b> Level or equivalent.	OR
Qualification on an According Member of one of the five professional institutes: UKIA, UKIE, UKII, A, UKID and	

Qualification as an Associate Member of one of the five professional institutes: HKIA, HKIE, HKILA, HKIP and HKIS, or equivalent.

### Examination

The purpose of the Examination is to test candidates' understanding of the core concept of green building under BEAM Plus assessment tools, and knowledge of how to support BEAM Plus projects. The Examination is a computer-based test and questions are randomly generated. Candidates are required to answer **60 multiple-choice questions within 90 minutes**. The Examination is **open-book – a hard copy of the Training Materials will be provided** at the examination centre.

Candidates can choose one of the designated Examination dates: **19 & 20 December 2016 at Hong Kong Examinations & Assessment Authority**, by indicating their preferred session on the registration form. Final assigned session will depend upon availability.

## Training and Examination Fee

Applicants must take the training and examination as a package. The registration fee for training and examination is not refundable. To register, please complete the registration form together with payment and send to BSL before the deadline.
