

Promotional BEAM Plus Certification Fee¹ Scale for Projects Outside Hong Kong

The following BEAM Plus certification fees are offered exclusively for non-Hong Kong projects to promote sustainable building practices beyond Hong Kong. The new time-limited promotional assessment fees are designed to gain broader recognition and sustainable growth for projects beyond Hong Kong, while maintaining our commitment to long term financial sustainability and equitable treatment of all clients. During this promotional period, fees for eligible overseas projects will be temporarily reduced by approximately 90% relative to our standard Hong Kong fee structure as a market entry incentive.
