You MUST fulfil one of the following:

- 1. A **degree or equivalent** in Built Environment or Interior Design related disciplines; and
- 2. At least 3 years postgraduate professional experience; and
- 3. Qualification as a **full member** of a relevant professional institute (HKIA, HKIE, HKILA, HKIP, HKIS, or equivalent) / member of one of the Professional Interior Design Associations:
- 1. Hong Kong Interior Design Association (HKIDA) Professional Member
- II. The Hong Kong Designers Association (HKDA) Fellow Member

OR

- A degree or equivalent in Built Environment or Interior Design related disciplines; and
- 2. At least 5 years postgraduate professional experience

OR

- 1. Age 35 or over; and
- 2. At least 10 years of experience in the interior design and fit-out of green premises; and
- 3. Applicants must have already attained a managerial position; and
- 4. <u>Submission of a paper (2,000 3,000 words in English / 3,000 4,000 in Chinese), to demonstrate your comprehensive knowledge and expertise in green building field and contribution to the green building movement. (NOTE)</u>

Complete the BEAM Pro Fundamental Course and proceed with the registration for BEAM Plus Interiors Training and Examination



Online Training Portal



Submit adequate relevant supporting documents to the BSL:

- ✓ CV/resume and;
- √ Certificate(s) of education and;
- ✓ Certificate(s) of professional institutes (if applicable)
- ✓ Certificate(s) of supporting organisations (if applicable)



The BSL, upon receipt of the application, shall inform the applicant of the approval status by email within 10 calendar days

Note:

- 1. Applicants must take the BEAM Plus Training and Examination as a package.
- 2. Only online registration is accepted.
- 3. Candidates must complete this course within TWO years after completion of the BEAM Pro Fundamental Course. Or else, candidates will be required to re-register for the up-to-date version of the Fundamental Course.
