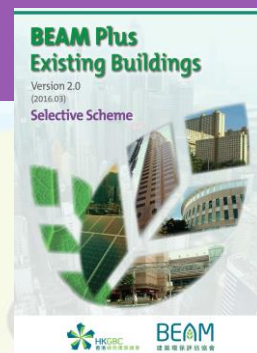
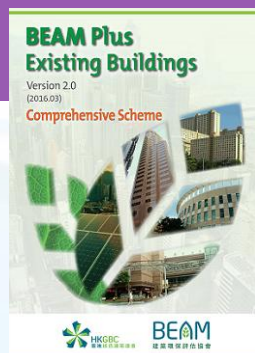
## Why BEAM Pro (EB v2.0)?

This course provides in-depth knowledge of BEAM Plus Existing Buildings (EB) assessment tool for practitioners who aim at earning the green building professional credential to demonstrate their expertise required for BEAM Plus submission.

## Who Can Enrol?

You MUST fulfil **one** of the following:

1. A **degree or equivalent** in Built Environment related disciplines; and
2. At least **3 years** postgraduate professional experience; and
3. Qualification as a **full** member of a relevant professional institute (HKIA, HKIE, HKIH, HKILA, HKIP, HKIS or equivalent, or possessing the type of membership in a professional body recognised by the Property Management Services Authority (PMSA) as acceptable for becoming Tier 1 Property Management Practitioners)

OR

1. A **degree or equivalent** in Built Environment, Housing Management, Facilities Management, Engineering, and related disciplines; and
2. At least **5 years** postgraduate experience related to the assessment of green buildings, or equivalent

OR

1. Age **35 or over**; and
2. At least **10 years** of experience in the operation and maintenance of green buildings; and
3. Applicants must have already attained a managerial position; and
4. Submission of a paper of **2,000 words**, on a relevant topic illustrating the applicants' expertise and experience in the green building field, as well as contribution to the green building movement. (For example: based on a property management case, or other original case created by the applicant)



## How to Enrol?

Register for an Online Training Portal Account and **BEAM Pro Fundamental Course** on Online Training Portal  
(Existing BEAM Pro can skip this step)



**Tutorial**

Complete the **BEAM Pro Fundamental Course** and proceed with the registration for **BEAM Plus Existing Buildings Training and Examination**



**Online Training Portal**

Submit adequate relevant supporting documents to the BSL:

- ✓ **CV/resume and;**
- ✓ **Certificate(s) of education and;**
- ✓ **Certificate(s) of professional institutes (if applicable)**

The BSL, upon receipt of the application, shall inform the applicant of the approval status by email within 10 calendar days

### **Note:**

1. Applicants must take the BEAM Plus (EB) Training and Examination as a package.
2. The fee for training and examination is not refundable.
3. Only online registration is accepted.
4. Candidates must complete this course within TWO years after completion of the BEAM Pro Fundamental Course. Or else, candidates will be required to re-register for the up-to-date version of the Fundamental Course.

## Training and Examination Schedule

### Video Training:

All year round

### Examination Time Slots for Selection:

19 September 2024 (Thu) or 20 September 2024 (Fri)  
10:00am – 12:00pm or 2:00pm – 4:00pm

### Examination Venue:

Hong Kong Examinations and Assessment Authority (HKEAA), 17 Tseuk Luk Street, San Po Kong, Kowloon, Hong Kong

Examination sessions and seats will be allocated on a **first-come-first-served** basis.

Registrants shall indicate the preference of examination time slots during the registration.

### Note:

Candidate is allowed to apply for examination reschedule ONCE, if he/she cannot attend the original scheduled date of examination. An administrative fee of \$600 will be charged. For details, please refer to BSL's website.



## Post-examination

Candidates will receive a provisional examination result showing “PASS/FAIL” immediately after the examination

Candidate who passes the examination will receive the notification from **Hong Kong Green Building Council** about the details of accreditation and credential maintenance within one month

Candidate who fails the examination could opt for Examination retake within one year from the first examination date

**Note:**

1. Candidates who are absent from the previous examination due to medical reason or personal issue are eligible to resit in the examination subject to the same payment. For details, please refer to BSL's website.
2. An appeal mechanism is applicable for the examination. For details, please refer to BSL's website.
